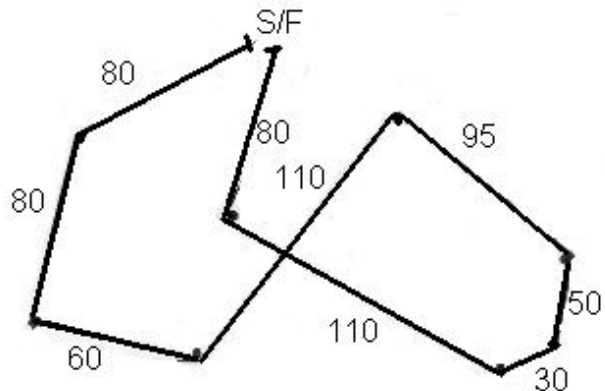

**Directions to the trial site**

**From I-25 North or South:** Just North of Cheyenne, WY on I-25, go to Exit 16 Horsecreek Rd. Turn right (east) on Horsecreek Road (this changes into Iron Mountain Rd).

Cross Yellowstone Road (2 1/2 miles from I-25) turn North (left) on Powderhouse Road (dirt road).

Go North on Powderhouse 0.5 miles to Sitting Bull. Turn right (east) on Sitting Bull (0.4 miles) to Empire. Turn left (north) on Empire and go 0.8 miles (curving to the right as Empire turns into Crazy Horse) to the entry gate on the left.
