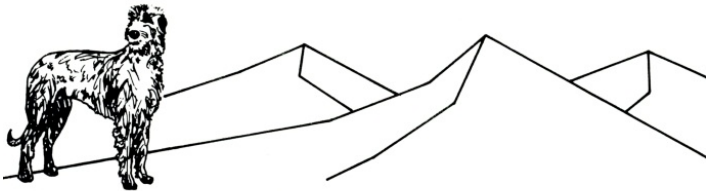


## 40 WONDERFUL YEARS: THE HISTORY OF THE RMIWA

Founded in the fall of 1973, the Rocky Mountain Irish Wolfhound Association (RMIWA) celebrates our 40<sup>th</sup> anniversary in 2013 – and the 20<sup>th</sup> Specialty Show. **Gerald (Jerry) McConnell**, the other “last of the founding members” still active in the club, originated the idea of a Rocky Mountain area Irish Wolfhound club. As I recall, Jerry first mentioned the idea to me sometime in the spring or summer of 1973 at an all-breed dog show. With increasing numbers of Irish wolfhounds in the region, there was a need for an organization of concerned, reputable owners. The founding members included **Jerry, Fredell (“Fred”) McConnell, Michael Hussey, Jude York Hussey, Greg Ward, and Mikelyn Ward**. Early discussions included charter members **Bob Mitchell** and **Dr. Jack England**. The first organizational meeting of the Rocky Mountain Irish Wolfhound Association was held toward in August 1973, at which time **Jerry McConnell** was to serve as Temporary Chairman and RMIWA approved a logo by **Michael Hussey** (below).

The group composed a letter to members of the IW fancy in Colorado and the surrounding area announcing the formation of the RMIWA, inviting them to join, and to attend the first meeting at the Husseys’ home in Evergreen, Colorado on September 15, 1973. At the meeting, the first officers were elected:

President - **Gerald McConnell**  
Vice President – **Michael Hussey**  
Secretary-Treasurer – **Mikelyn Ward**

The officers were voted as the Board of Directors. Dues were set at \$10 for an individual membership and \$15 per family membership. We agreed to quarterly meetings and the secretary would serve as newsletter editor. The second Association meeting was December 2, 1973.

At the December meeting, **Robert Mitchell** was elected to serve as Director-at-Large. Additionally, a constitution and by-laws proposed by the officers was approved. The RMIWA now had 25 members from four states. Also, the RMIWA’s first rescue group, “Homes for Hounds,” had helped find new homes for two “misplaced” IWs.

The third meeting was scheduled for March 16, 1974, following the Denver St. Patrick’s Day Parade, in which the Irish Wolfhounds marched as part of the “Honor Division.” To this day, the wolfhounds march under the RMIWA banner. The Association’s first newsletter was published February 13, 1974 with results of the December meeting. **The RMIWA was on its way!**

RMIWA’s first IW Specialty Fun Match was July 31, 1974 in Aspen, CO. With an entry of 10 wolfhounds, Judge

Raymond Bay named Four Leaf Koa of Berdot owned by the **O’Donnells** as Winners Bitch and Best in Match.

The newsletter of November 5, 1974 included the ballot for the 1975 officers and Director at Large. All of the original officers and director were re-nominated with the addition of **Jude York Hussey** as Treasurer. (The club had grown enough to separate the offices of Secretary and Treasurer.) Also on the ballot was the RMIWA’s first Code of Ethics. To allow for additional nominations, the club would vote at the November meeting. At the close of the club’s first year, **Michael Hussey** and **Jude York Hussey** were named as the newsletter editors. The club now had 29 memberships with 43 members. RMIWA was working towards getting AKC acceptance.

On April 20, 1975 “Friends of the RMIWA” held an “all hound” fun match as a fundraiser. This would become an annual event for the next three years.

The July 21, 1975 newsletter announced that a “formal” welfare committee was established with **Greg Ward** as chairperson. Also reported was RMIWA had been approved by the American Sighthound Field Association (ASFA) as a member club and that the RMIWA’s first field trial was scheduled for May 4, 1975. However, because of some confusion regarding ASFA rules, the trial was postponed. The membership list showed 42 memberships with 65 members.

Meanwhile, the AKC sent RMIWA a set of guidelines for a constitution and by-laws to meet AKC requirements – necessary for an AKC sanctioned match. The Board redrafted RMIWA’s original constitution and by-laws to conform to AKC’s requirements.

RMIWA held its second Specialty on August 16, 1975 in Bergen Park, Colorado. **Nelson Huber** judged 31 IWs entered in the classes and 5 entries in the parade of champions. Winners Bitch and Best Open in Match was Kirkaelin Annelsa, owned by **Dr. Jack England**. Best Puppy in Match was (Puppy Dog 6-9 months) Joshua Snap, owned by **Claude and Pat Delaverdac**.

At the meeting on October 11, 1975 the board passed an amendment to the by-laws that allowed the addition of three more directors, bringing the total number of

directors to four. The nominations for 1976 officers and directors were announced. They included:

President – **Michael Hussey**  
Vice President – **Robert Mitchell**  
Secretary – **Fredi McConnell**  
Treasurer – **Glenn Vollmer**  
Directors (4) – **Michael John Bowen, Gerald McConnell, Alison Sanders, and Louis Walsh**

And so ended the first two years as RMIWA entered its third year: 1976. As these were the formative years, I have provided more detail. To keep this history at a (somewhat) reasonable length, I will hit the “highlights” from here on:

**January 1976** RMIWA “resident” attorney, **Brian McCauley**, drew up a release form for the Welfare Committee. The Association adopted the policy that all IWs placed through the welfare committee would be spayed or neutered prior to placement.

**March 1976** RMIWA sent its first delegates, **Steven Cote** and **Michael John Bowen**, to an ASFA Annual Convention of Delegates.

**April 1976** RMIWA held its first ASFA sanctioned lure coursing field trial. RMIWA held three more in 1976 – two in July (in Steamboat Springs), and one in October.

**June 1976** RMIWA held its first Awards Banquet (for 1975 awards) at Raffles Restaurant during the Colorado Centennial Canine Circuit. Open to all IW owners, 43 attended. This year initiated the presentation of the RMIWA medallion, created by member artist **Sally Polk**, to the top conformation, obedience and lure coursing IWs owned by an RMIWA member.

**August 1976** A new constitution and by-laws were passed. AKC turned down RMIWA’s request to become a club of record because of the regional nature of our membership and club name. (This was to be a sticking point for more than a decade.)

**February 1978** RMIWA held its last “Friends of the RMIWA” all-hound group fun match.

**June 1977** IWCA held the National Specialty in Colorado Springs. RMIWA held its second awards banquet and an IW specialty ASFA lure coursing trail in conjunction with the National Specialty events.

**May 1978** RMIWA held its first out-of-state General Membership meeting at the home of **Alison Sanders** in Santa Fe, NM. Alison had hosted a number of unofficial meetings in conjunction with the New Mexico Kennel Club show in Santa Fe – always well-attended and enjoyable.

**November 1979** RMIWA filed papers in the State of Colorado incorporating as a non-profit organization.

**March 1980** RMIWA revised the Code of Ethics.

**June 1981** **Jude York Hussey** became the sole editor of the RMIWA newsletter. It was approved to increase the number of Association meetings from four to six per year.

**April 17, 1982** RMIWA held its first AKC Sanctioned B-OB Specialty Match in Colorado Springs with 22 IWs in conformation and three in obedience. **Beverly Little** judged conformation and **Jeannie Roberts** judged obedience. Best in Match was Kirkaelin Dolly owned by **Dr. Jack England**. High-scoring obedience was Fairfield Celtic Pride, FCh owned by **Norb and Rita Nothstein**.

The **June 28, 1982** issue of the newsletter introduced the new and improved (and current) official club RMIWA logo, again created by **Michael Hussey** (see below).

**June 12, 1991** RMIWA received word from AKC that it was eligible to apply for A-OA status – too late for the 1991 match. On **May 24, 1992**, RMIWA held its first A-OA match with 25 IWs – 27 in conformation and one in obedience. The conformation judge was **John Lewington** (Australia) judged conformation and **Mickey Ruben** judged obedience. The Best of Breed in the A-Match was St. Leger Jayne Eilid O’Reilly, owned by **Kathy Dykstra**; Best of Opposite Sex was Lochbay’s Archangel, owned by **Joke Tucker van den Berg**. High-scoring obedience IW was Stoneybrook Asilinn O’Reilly, F.Ch. owned by **Kathy Dykstra**, and **Lynn & Judy Simon**.

Starting in **1992**, the newsletter went from four to six issues per year. With issue Volume XIX, Number 6 the newsletter had an official name: **The Hound’s Pause** as submitted by **Barb Patterson** and approved by members.

On **May 30, 1993**, RMIWA held its second AKC sanctioned A-OA match. **Elizabeth Murphy** (Ireland) judged. This was also RMIWA’s 20<sup>th</sup> match. Following the match, it was announced that AKC had approved proposed changes to RMIWA’s constitution and by-laws and, pending the membership’s approval, RMIWA will have met all of AKC’s requirements necessary for RMIWA to apply for a pointed Irish Wolfhound specialty. The new constitution and by-laws were passed at the **September 25, 1993** general membership meeting and went into effect **January 1, 1994**. The first show was held on Friday,

**September 2, 1994. Joel Samaha** judged. (All specialty information is listed in this catalog, so I won't repeat here.)

RMIWA held its first AKC Junior Coursing (JC) Tests on **April 23 and 24, 1994**. Fifty dogs were entered on Saturday, the 23<sup>rd</sup> – a record entry for an AKC JC test at the time. RMIWA held its first AKC Lure Coursing Trial weekend **April 22 and 23, 1995**.

At the RMIWA meeting in July **1999**, the RMIWA Board initiated the RMIWA Service Award (renamed in 2004 “the Rusty Mueller Service Award” in memory of RMIWA member **Mary “Rusty” Mueller**). The award is to be “awarded to a club member who has made a significant contribution to the breed and/or the club for an extended period of time that, in the opinion of the Board, merits special recognition.” The award is considered annually by the Board at its July meeting. The award will not necessarily be awarded every year. If given, the award is presented during the lunch break at the RMIWA Specialty Show. The first award was presented to **Barbara Raichle** at the 1999 RMIWA Specialty.

RMIWA held its first All-Breed Large Gazehound Racing Association (LGRA) race weekend on **July 17<sup>th</sup> and 18<sup>th</sup>, 2004**. The race on the 17<sup>th</sup> was also the first all-breed LGRA race held in Colorado. (However, the Borzoi Club of America had previously held a specialty race, so we can't claim the first LGRA race in Colorado.)

A number of RMIWA members and their IWs marched in the Boulder St. Patrick's Day Parade (Sunday, the day after the Denver St. Patrick's Day Parade). Billed as the “world's shortest St. Patrick's Day Parade,” the parade extended one block down and one block back. Members have participated in this parade ever since. It will become RMIWA's “parade of choice” in 2014.

In the interest of “brevity,” I'll close with that last of the “firsts.” However, the Association continues to evolve – it again revised the constitution and by-laws two years ago in 2011 to reflect changing times and needs. We look = to the future with anticipation, and a deep appreciation for the world's greatest companions, the reason for there being an RMIWA – **the Irish Wolfhound!**
