RULES AND REGULATIONS

Roll Call: Flexible Roll Call will be used. When held concurrently, a dog entered in both tests would be allowed to complete both runs in succession (back to back) without having to wait for one event to finish before the next can begin. The length of rest time between runs will be the decision of the owner. **A second inspection is required by AKC rules before the 2nd run.**

PRE-TEST BRIEFING/ Owners meeting will not be held, volunteers are available to help with release, catch and questions. If you are new to FastCAT let us know at the Registration Station and we will be happy to help you and answer questions. Running order will be determined by the selection of time blocks on entry form. We will accommodate changes as best as possible. *Workers will have priority running order to allow for the track to be tested and all workers to be in place for the event.

ELIGIBLE DOGS Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/ cryptorchid dogs are eligible to participate. Females in season may not participate. Refunds will be given for lameness or in-season females.

NOTICE TO ALL EXHIBITORS

Facilities

The track will be fenced and the grounds are fully fenced and gated. Portable Restrooms will be available at the site. Running order will be approximated and determined by time blocks selected on entry form. Concurrent tests allow for entrants to arrive, run, cool down, run again and leave. The lure will be a continuous loop machine with white plastic bags. Timer will be a break-the-beam FarmTec Curtain timer with 2 stopwatches as backup.

The Huntmaster is responsible for field safety and therefore s/he is in complete charge of all dogs and handlers on the field. In service to this responsibility, s/he has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog. Listen to the Huntmaster and follow all instructions promptly and swiftly.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.

General

This is a rain or shine event. No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

A penalty of \$5.00 may be assessed for any loose dogs not competing in the course in progress. Persons exhibiting conduct detrimental to AKC/RMIWA/any dogs(s) and/or other person(s) will be asked to leave the test site.

The event-hosting club, its agents, members, representatives, volunteers, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.

All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. All persons and animals attending these shows grant the club the right to use their likeness and voice in any matter without further consent.

Entry fees submitted and accepted will be refunded in full if the withdrawal of said entries are requested by the dog's owner or agent prior to the closing deadline for entries. Requests must be made in writing to the Field Secretary. No refunds for pre-entry fees unless the entered dog upon inspection is lame, unfit to compete, or in season.

Females in season are NOT allowed on the site.

Late, incomplete, unsigned, unpaid or conditional entries, or entries not containing the "Agreement" found on the Official AKC Entry Form will not be accepted. Electronic signature will be accepted

Substitution of dogs will be accepted at the time of roll call/inspection. Once inspection is complete, no further substitution will be allowable.

A return check fee of \$35.00 will be assessed for any check(s) returned for insufficient funds.

DIRECTIONS FROM THE SHOW SITE TO Veterinary Emergency Group: Exit parking lot on 25th Ave east to Miller Street (left turn), north one block on Miller to 26th Ave (right turn), east on 26th Ave to Kipling (left turn), south on Kipling to 20th Ave(left) east 3 miles (past traffic circle) to hospital--the hospital is on the left (approximately 7 minutes).

Note: ON CALL VETERINARIAN will be available to treat any dog that becomes ill or injured at the test during show hours. It will be the responsibility of the owner or owner's agent to transport the dog to the veterinarian and for any cost associated with the dog's illness or injury. Exhibitors should follow veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases & have appropriate vaccinations.

RUNNING YOUR DOG --Collars and Leashes Bring two leashes, one for release at the start and one for catching your dog at the finish. It takes two people to release and catch your dog. Volunteers will be available to help with release and with catch. **TIP:** It works best if you have someone release your dog and you catch them. Be sure to ask for help, we are happy to work with you.

Dogs may wear any collar **except** the following-- a choker collar, a collar with prongs, an electronic training collar or a harness. The collar should be snug to minimize the chances of getting hung up on something during the run. Owners should be aware that tags hanging from the collar will not be required to be removed by the club. The owner will determine the best way to prevent collars and tags from being entangled on something during the run. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility for the safety of the dog regarding the dog's collar and paraphernalia on the dog. **A harness is permitted to be worn on the grounds, but the dog can not run with a harness.**

Running Order Process-- The Process has changed

Everyone registered by close of registration will be assigned a time block based on preferred block selection in entry form and availability. Confirmation email will be sent after Pre-Registration closes. Since dogs can run concurrently you may choose to run back to back or allow some time between

runs in your time block. Workers will have priority running order to allow for the track to be tested and all workers to be in place for the event.

WE WILL BE HOLDING A FLEXIBLE ROLL CALL.

Scheduled groups of dogs will enter the gate in during their designated time blocks according to your scheduled run time(if you are later we can accommodate you). Stations will be set up to process and move everyone through the test.

STATION 1: DOG Registration/Roll Call -- Information will be verified so we can record the correct times for your dog. **No registration/time cards will be given out, you will receive time block specific event wristband. Your dog's time and qualifying ribbon will be available at the exit. If you believe you have qualified for a New Title please pick up your ribbon at the exit station.**

STATION 2: Dog Safety -- Each dog will be inspected for lameness, fitness to compete, and check females to ensure they are **NOT** in **season**. All dogs to be inspected must be presented WITHOUT TAPE, BANDAGES, or WRAPPING/COVERINGS of any kind (Coats, blankets, etc.). If, in the opinion of the inspection committee, any entry is found to be lame, unfit to compete or in season, they shall not be allowed to test, and the applicable entry fees shall be refunded. This will be done through Self Inspection, which will be recorded by an Observer.

STATION 3: Start Staging Area -- Releaser with dog will proceed (Be sure to practice social distancing) to the staging area. Catchers will proceed to the Catch area (with a leash) Be sure to practice social distancing. If you need help catching, please let the Stager know, they will alert the Dog Catchers to catch your dog.

STATION 4: Start Line -- Huntmaster will guide dog and Releaser to the start line. Once the dog has run, the releaser will exit the starting area. If you need assistance from a catcher, proceed to the catch area to collect your dog.

STATION 5: Catch Area -- The Catcher, will leash the dog after the run. Catcher, with the dog on leash, will exit the catch area, and walk to the Exit station where you will pick up your time, qualifying ribbon and New Title Ribbon if applicable. There will be workers in the Catch area to assist with catching your dog if needed.

STATION 6: Timers and Recorder will be at the finish line. Each run will use the break-the-beam timer and back up stopwatch. Run information will not be distributed at this station.

STATION 7: You will pick up your qualifying ribbon with the time recorded. If you are running a second run you will need to return to STATION 1 at your scheduled running time for a second inspection (this is an AKC rule)..

Complete the official AKC entry form (located at the end of this premium list) for each **dog. ONE ENTRY FORM PER DOG.** A dog may only enter once per event, there are two events each day. Separate fee for each dog and each day. Electronic entries are encouraged due to COVID, your electronic submission is considered a legal signature. Payments are made separate from the registration form.

Fast CAT - Summary Description The Fast CAT Test is a timed 100-yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner. The following is a summary of how **the event** is structured.

How Does Fast CAT Work?

1. Fast CAT is a timed straight race of 100 yards.
2. Dogs run singularly.
3. The dog's time to complete the 100-yard dash is converted into MPHs. The time is converted to Miles Per Hour (MPH) using the following calculation -- 204.545 divided by the dog's time.
FORMULA: $204.545 / \text{Time} = \text{MPH} \times \text{HANDICAP} = \text{POINTS}$
4. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:
 - 18" or greater = handicap is 1.0
 - 12" up to less than 18" = handicap is 1.5
 - Below 12" = handicap is 2.0
5. Points = MPH multiplied by the dog's handicap
6. Fast CAT titles suffix titles are earned at designated milestones:
 - BCAT = 150 points
 - DCAT = 500 points
 - FCAT = 1,000 points
 - FCAT# = every additional 500 points
7. Top 20 by Breed by Year: The AKC Fast CAT website will feature the Top 20 Fastest Dogs by Breed by Year national standings. The standings will be updated as event results are processed.
8. Eligibility to Participate: Open to all dogs at least 12 months of age that are individually registered/listed with the AKC. This includes dogs recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not enter. A dog may enter only once per event. (An event number defines an event.)
9. An inspection committee shall inspect each entry for lameness, fitness to compete and females in season. If necessary, the inspection committee is responsible for measuring dogs to determine their height at the withers.
10. Safety: Safety is of utmost importance. It is the responsibility of the event committee to ensure the safety of the course, the equipment and the conduct of those involved with the event. The event committee will run test dogs prior to the start of the event to ensure that the equipment functions properly and all personnel understand their jobs. Prior to moving the lure to position it for the start, the lure operator shall announce, "**hold your dogs**" in order to caution owners. Listen for this command.
11. The Start: Dogs may start up to 10 feet behind the starting line.
12. The Finish: The club will provide enough room for a safe run-out area. The complete course is fenced, in addition, the test grounds are fenced. It is recommended that an owner or someone familiar with the dog stand at the finish to catch the dog once the course has been completed.
13. Timing Devices: The time to complete the 100-yard dash is recorded to the nearest 1/100th of a second (e.g. 9.11). The club will use break the-beam timer equipment to obtain the time. As a back-up 2 stopwatches are used, there shall be two timers positioned at the finish line. The recorder will record the timer; stopwatch times will only be used if the break-the-beam timer malfunctions. An

individual at the start line shall signal with an arm drop the moment the nose of the dog crosses the start line. The timers shall start their stopwatches at the bottom of the arm drop. The timers shall stop their watches when the nose of the dog crosses the finish line. The times from the two stopwatches shall be averaged to determine the recorded time.

14. Lure Equipment: Club will use a continuous loop system.

15. Lure: A white plastic bag will be used for the lure.

16. Course/Fencing: The course will be the grass field

17. The Huntmaster has control of the course. In summary, the Huntmaster is in charge of all dogs and handlers on the field, shall ensure handlers understand safe release and retrieval procedures, shall ensure the lure is properly positioned, shall ensure the lure operator, timers and starting line signal person are ready, shall signal the lure operator to start the lure and shall give the verbal signal **"tallyho"** to release the dog.

18. Clubs will be limited to twelve Fast CAT events per calendar year. A club may not hold more than two Fast CAT events on the same day. A test must start and conclude on the same day.

19. RMIWA Fast CAT is a stand-alone event.

20. Entries: All participants must fill out an entry form as provided in the event's premium list. RMIWA will accept entries prior to the event and should the test not fill will accept day-of-event entries. The specifics of how entries will be accepted is explained in the premium. The limit of 200 dogs per day is the number of entries it will accept in these Fast CAT events.

Complete regulations governing Fast CAT can be found on AKC Fast Cat website and will appear in Chapter 16 of the Regulations for Lure Coursing.

10 Tips for Beginners (and Reminders for those with experience)

- **Bring 2 leashes--one to release your dog and one to catch your dog. It works best to have someone release your dog and someone to catch your dog.**
- **If you are solo there are many helpers to ask at the test, just be sure to plan ahead.**
- **Be ready at the starting line-- pay attention to your run time and have your dog and releaser ready to go**
- **Be ready at the finish line**
- **Have your catcher and a leash at the finish line ready to catch.**
- **Qualifying Ribbons and run times will be available at the exit station.**
- **Your dog can run with collar and tags, and no muzzle --this is at your discretion.**
- **Cool down is important--Walk your dog back from the finish line thru the exit station where you will pick up your time, qualifying ribbon and New Title Ribbon if applicable.**
- **As a courtesy to those running; do not walk near the course--even a small distraction can cause a dog to lose focus and slow down.**
- **Dogs must run the course by themselves.**
- **See the AKC rules for specifics.**
- **You're getting exercise too!! Relax and have fun!!**

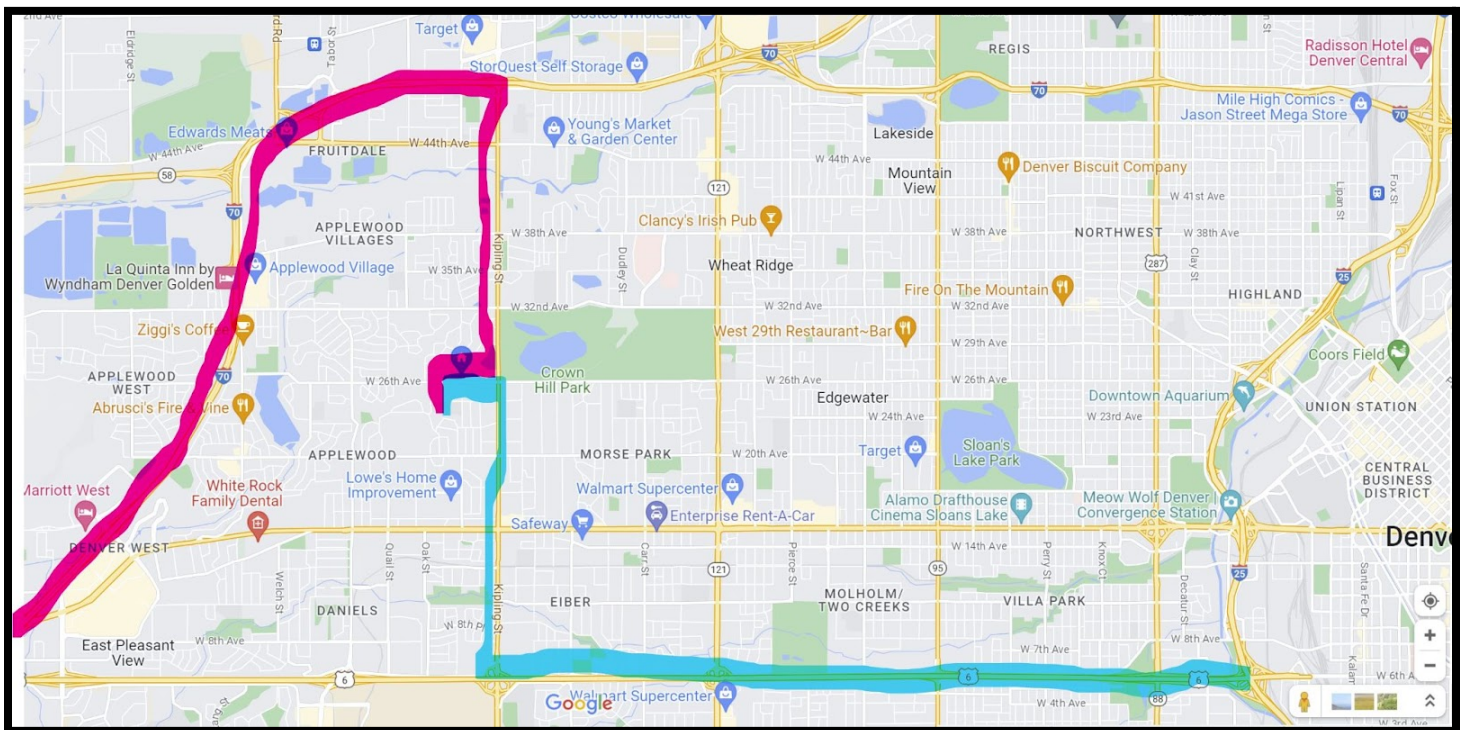
