\$35.00 for the FIRST ENTRY in CONFORMATION & OBEDIENCE  
\$25.00 for each additional entry of the same dog in the same event  
\$25.00 for Sweepstakes  
\$25.00 for Stud Dog, Brood Bitch, Brace (as a unit)  
\$15.00 for Junior Showmanship (Friday only)  
\$35.00 for the FIRST ENTRY in RALLY EVENT  
\$25.00 for each additional entry of the same dog in above RALLY event

NOTE: Conformation and Obedience on Thursday is one event number. Rally is a separate event number. Conformation on Friday is also a separate event number. Additional entries do not transfer from one event number to another.

ENTRY FEES already include a \$.50 AKC RECORDING FEE and a \$3.00 EVENT FEE for AKC.

**CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.**

Entry fee is not refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of the Show Committee.

**Post Dated Checks & Returned Checks** do not constitute a valid entry fee. The Show Secretary adds a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

No entry fees are refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes and/or any other cause beyond the control of the Club or the Show Secretary.

No entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.

Entries are not accepted without fees or signatures. There are **no refunds** for duplicate entries. Changes, additions or corrections to entry forms must be received in writing or email prior to close of entries. Those received by telephone are not acceptable.

No dog wrongly entered in a class may be transferred to another class (except in case of wrong sex), nor can a dog be withdrawn after entries have closed. The owner or agent assumes all responsibilities for wrong or incomplete information of the entry blank.

Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee is refunded in event of such errors or cancellation of entries after the published closing date.

Entries must be made on an Official AKC entry form or photocopy of the Official AKC entry form with the Agreement and Rules on the reverse side or they cannot be accepted.

**Confirmation of Entry** is sent to the email address(s) on the Official AKC entry form within 48 hours of receipt. If you do not receive email confirmation promptly, please contact the show secretary. **Confirmation of Entry and Judging Schedule** is sent via postal mail to the address on the Official AKC entry form after the closing date, unless otherwise agreed to in email notification.

The Show Site will be available to exhibitors at 4:00pm to 10:00pm on Wednesday August 28, 2024. Thursday and Friday August 29 and August 30, 2024 from 7:00am to 10:00pm

The show grounds constitute the building & the outside grounds and parking lot.

All regulations governing the use of this facility, and all regulations and decisions of the Show Committee of this show giving club on this day will be strictly enforced, including and not recorded in this Premium List.

Exhibitors wishing to set-up exercise pens, crates, and pop-up tents can begin set-up after ALL RINGS AND CLUB EQUIPMENT SET-UP IS COMPLETE NO EARLIER THEN 6:00PM on Wednesday.

Exhibitors are responsible for cleaning up after their own dogs AT ALL TIMES. Dumping of dog food, dog waste or grooming residue into the restroom sinks and toilets is strictly prohibited!

NO dogs will be allowed in the restrooms. NO un-entered dogs allowed on the show grounds.

No baby strollers are allowed in the show buildings.

Parents are solely responsible for their children and are expected to keep them supervised and controlled at all times for their own safety.

The Show Committee will exercise its right to suspend any person from all AKC privileges for conduct prejudicial to the best interests of purebred dogs which includes abuse of a motel/hotel facility (Chapter 7, Section 1 of *the Rules Applying to Registration & Discipline*).

Some hotels have a limit on the number of dogs accepted. When making reservations, please inquire into dog fees and tell them you are in town for the dog show to be eligible for dog show rates, if applicable. Please see our host hotel information for rates and additional information.

You are **REQUIRED** to clean up the area after walking your dogs at any hotel/motel. **DO NOT** leave dogs unattended inside any motel room or groom your dog inside any room. Please use exercise pens if provided.

All parks and the lawns at the Greeley Tribune Building and Lincoln Park are OFF LIMITS to dogs except Island Grove. Violators in Lincoln Park may be ticketed.

## **EXHIBITOR INFORMATION:**

Dogs only need to be present for scheduled judging and are released if not needed for further judging.

Dogs must be ready for judging. Neither the Club nor its Show Secretary are responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class.  
**Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property while at or on the show grounds, or in transit to or from the show. And furthermore, assumes no responsibility for injury to children.

The hosting club exercises every precaution for the safety of dogs exhibited, but it must be understood that neither the club, site or show secretary are responsible for any injury, damage, or loss. It is understood that all dogs at this show are in the care and custody of the owners or owner's agents during the entire show weekend.

No double handling is permitted at these shows. Individuals who attempt to double handle from outside the ring are subject to action by the Show Committee.

No generators are to be operated within 100 feet of any ring during judging times.

There shall be no drilling or intensive / abusive training of dogs on the show grounds.

At a specialty show the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

**This club does not agree to arbitrate claims as set forth in the official AKC entry form for this event.**

Dogs must be in control at all times. Please note: AKC Board Policy Special training devices that are used to control and train dogs, including but not limited to, collars with prongs, electronic collars used with transmitters, muzzles and head collars may not be used on dogs at AKC events, except as allowed in the AKC Rules, Regulations, and policies.

Exhibitors are required to clean up after the dogs that they are exhibiting, or which are under their care or control. This requirement includes both while in the ring or at any location on our show site. Clean-up tools and supplies are available at each ring and at other convenient locations throughout the show grounds.

Exhibitors should follow their veterinarian recommendations to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Dogs owned or co-owned or bred by Officers, Show Chair, members of the Event Committee and members of their households and photographers are eligible for entry at this event.

All persons entering this dog show/event, hereby waive any claim for damages against the Rocky Mountain Irish Wolfhound Association, it's members or the show secretary in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. The club(s) is solely responsible for determining if the said animal is in distress.

## **DOG PARKS IN GREELEY**

The City of Greeley Ordinance prohibits dogs in many of their city parks. For example, All parks and the lawns at the Greeley Tribune Building and Lincoln Park are OFF LIMITS to dogs except Island Grove. Violators in Lincoln Park may be ticketed. ## **CLASS INFORMATION**

### **REGULAR CLASSES**

The following classes are available for both dogs and bitches.

Puppy, 6 mo & under 9 mo	Bred-by-Exhibitor under 12 months
Puppy, 9 mo & under 12 mo	Bred-by-Exhibitor over 12 months
12 mo & under 15 mo	American-Bred
15 mo & under 18 mo	Open
Novice* (please verify eligibility before entering, see below)	Best of Breed

### **NOVICE REQUIREMENTS**

Novice Class eligibility: dogs that have not previously won 3 first places in Novice Class, a 1st place in Amateur- Owner-Handler, Bred-by-Exhibitor, American-bred, or Open Classes or who have not earned one or more points toward their championship.

### **BEST OF BREED COMPETITION**

Effective for all shows held on or after July 1, 1980, dogs which according to their owner's records have completed the requirements for a Championship after the Closing of Entries for this show, but whose Championships are unconfirmed, may be transferred from one of the Regular Classes to the Best of Breed or Variety Competition, provided this transfer is made by the Show Secretary at least one-hour prior to the start of the judging at this show. (American Kennel Club Rule, Chapter 11, Section 6)

### **BRED BY EXHIBITOR REQUIREMENTS**

All dogs entered in the Bred-By Class must be individually registered with the AKC, the person handling the dog must be a breeder of record and an owner or co-owner of the dog.

## **NON-REGULAR CLASSES – Involving Single Dog Entries**

### **VETERAN DOG / BITCH CLASS\***

A class for dogs/bitches six ( 6 ) years and older

Veteran classes are divided by age for both dogs and bitches:

6 years and under 8 years	8 years and older
---------------------------	-------------------

### **FIELD TRIAL DOGS / BITCHES\***

All entries in these classes must have earned AKC Field Championship; ASFA Field Championship; LCM or Senior Courser Titles.

\*1<sup>st</sup> place winners of the above Veteran and Field Trial classes are eligible to compete for Best of Breed IF undefeated in any other class at this show.

### **ALTERED DOGS / BITCHES**

A class for dogs/bitches which are spayed or neutered and not a champion of record. Placements are awarded for 1st through 4th place for each sex. A single class for dogs/bitches altered dogs. Entry fee follows the conformation rate of \$35.00 for each Irish Wolfhound entered in Altered. Enter by writing "Altered" under the Classes on entry form.

**ALTERED WINNERS DOG / BITCH.** For 1<sup>st</sup> place winners of Altered Dog / Bitch classes

**BEST ENTRY IN ALTERED CLASSES.** Competition between Altered Winners Dog and Altered Winners Bitch

### **BEST PUPPY IN REGULAR CLASSES**

For 1<sup>st</sup> place winners of dog/bitch 6-9 month and 9-12 month classes.

### **BEST ENTRY IN VETERAN CLASSES**

For 1<sup>st</sup> place winners from dog/bitch Veteran classes.

Following the selection of Best Entry In Veteran Classes there is a presentation of a special recognition gift to the Oldest Veteran Entered in the RMIWA Specialty ..... **Memento & Rosette**

## **NON-REGULAR CLASSES – Involving Multiple Dog Entries**

### **STUD DOG / BROOD BITCH CLASS\***

For Stud Dogs/Brood Bitches and two (2) of their Get/Produce. Stud Dogs/Brood Bitches must be entered in the class and must be shown in the ring with their Get/Produce. Owners of the Stud Dog need not necessarily be the owners of the Get. Get/Produce only to be judged based on their merits. The winner of this class is not eligible for Best of Breed competition by virtue of having won this class. Get/Produce must be entered in one of the regular classes. Neutered/Spayed dogs are allowed in this class.

### **BRACE\***

For two dogs of the same recognized breed or variety that are similar in appearance, performing in unison and presented by a maximum of two handlers, with at least one common owner. Both dogs in the Brace must be entered in another class at this show.

### **TEAM\***

For four dogs of the same recognized breed or variety that are similar in appearance, performing in unison and presented by a maximum of four handlers, with at least one common owner. All dogs in the Team must be entered in another class at this show.

\*No one of the dogs or bitches making up the entries above that were judged first are eligible to compete for Best of Breed by virtue of having won in these Non-regular classes.

#### **NOVICE JUNIOR CLASS**

For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

#### **NOVICE INTERMEDIATE CLASS**

For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

#### **NOVICE SENIOR CLASS**

For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

#### **OPEN JUNIOR CLASS**

For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

#### **OPEN INTERMEDIATE CLASS**

For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

#### **OPEN SENIOR CLASS**

For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

#### **MASTER CLASS**

*(Effective date of January 1, 2018)* For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior wins with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1-October 31 of the following year. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

Each dog handled in a regular Junior Showmanship Class must be entered and shown in one of the breed classes at the show, or must be entered for Junior Showmanship only. However, a dog that must be withdrawn for good and sufficient reasons, such as a bitch in season or a veterinarian's excuse may be replaced by another dog meeting the same ownership requirements. Such substitution must be requested in writing stating the reason for the substitution and must be accompanied by an official AKC entry form.

### **Obedience/Rally Move Ups**

The provisions for transfers in the Obedience and Rally Regulations were established to allow a dog to be transferred to another class, from which it was originally entered after entries have closed, if the dog has earned a title. ## **RMIWA CHALLENGE TROPHIES**

The following **RMIWA CHALLENGE TROPHIES** are offered through The Rocky Mountain Irish Wolfhound Association for competition at its show only. Challenge Trophies are offered on a three-time, win basis for permanent possession to the RMIWA member owner winning the award three times, not necessarily with the same dog.

The club retains possession of all Challenge trophies until retired. Interim winners have their photograph taken with the trophy at the Specialty and then are required to return the trophy immediately to the Club's Permanent Trophy Chairman. No award is mailed. If a trophy listed is unavailable, a Trophy of equal or greater value is awarded. All claims for trophies and other prizes must be made in the judging ring before the completion of the judging of the breed, and the Event Secretary advised at once in the event of any discrepancy.

For permanent possession, the trophy must be won three times by the exact same owner(s) (and co-owners) (or breeder(s), for those awarded to the winning dog's breeder), not necessarily with the same dog, nor at consecutive shows. Names are verified by the AKC registration and catalog entry. Co-owned hounds are considered **ONLY** for the owner with whom the hound resides. If won 3 times and permanent possession is desired, the trophy must be replaced

with a trophy of equal or greater value, no less than \$300. Transfer of the retired Trophy takes place when the club has received and verified receipt of the new trophy. If re-donated to the club, the name of the trophy is then noted as [trophy name] re-donated by [retired winner]. If re-donating a trophy with a new name, the cost of renaming (engraving, etc.) a retired trophy is incurred by the winner. Any Challenge Trophies won and retired during the 1st specialty show during a 2 Specialty event are not available to be won at the 2nd specialty show.

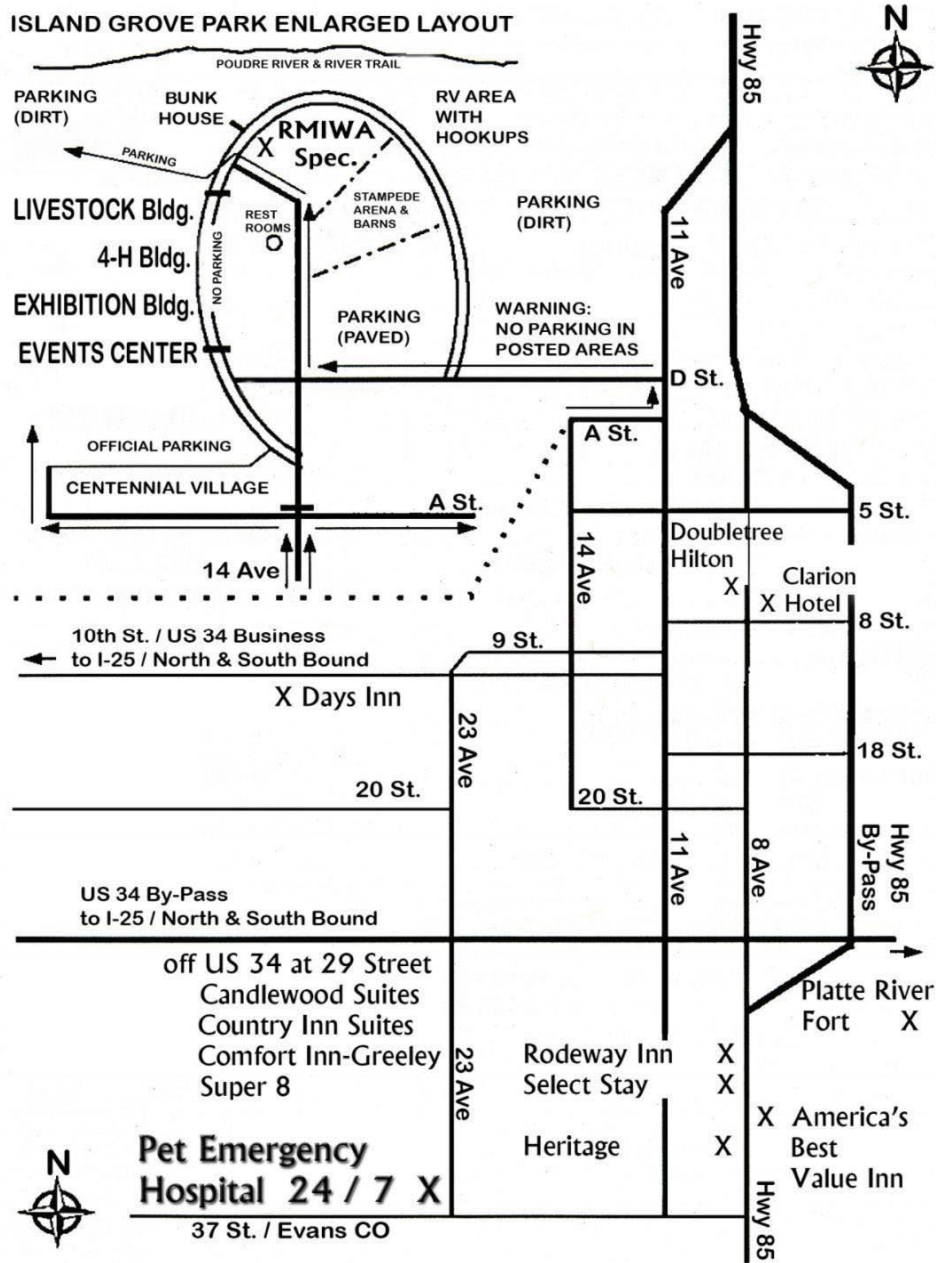
